**BYLAW 09-2023**

A BY-LAW OF THE TOWN OF BRUDERHEIM IN THE PROVINCE OF ALBERTA TO ESTABLISH FEES, RATES AND CHARGES FOR SERVICES PROVIDED BY THE MUNICIPALITY.

WHEREAS the Municipal Government Act, SA 2000, Chapter M-26 (hereinafter referred to as "the Act"), as amended, provides that a municipality may pass bylaws for municipal purposes respecting services provided by the municipality;

AND WHEREAS the Act provides for the establishment of fees for licenses, permits and approvals by bylaw;

AND WHEREAS the Act provides for provision of municipal utility services subject to the terms, costs or charges established by Council;

AND WHEREAS the Act provides that a municipality can provide copies of information on payment of a reasonable fee as established by bylaw;

NOW THEREFORE the Council of the Town of Bruderheim, in the Province of Alberta, enacts as follows:




This Bylaw comes into force and effect on January 1, 2024.
