TOWN OF BRUDERHEIM BYLAW NO. 03-2022

A bylaw of the Town of Bruderheim, in the Province of Alberta, to provide for the direction and control of the Town of Bruderheim emergency operations under the *Emergency Management Act*.

WHEREAS:

- i) pursuant to *Emergency Management Act, RSA 2000, c. E-6.8,* The Town of Bruderheim is responsible for the direction and control of the Town's emergency responses, and the preparation and approval of emergency plans and programs.
- ii) pursuant to Section 11.1 of the Emergency Management Act, RSA 2000, cE6.8, the Council of the Town of Bruderheim must appoint an Emergency Advisory Committee consisting of a member or members of Town of Bruderheim Council to advise on the development of emergency plans and programs, and provide for the payment of expenses of the members of the emergency advisory committee;
- iii) pursuant to section 11.2 of the Emergency Management Act, RSA 2000, cE-6.8, Town of Bruderheim Council must maintain an Emergency Management Agency to act as its agent in exercising Town of Bruderheim Council's powers and duties under the Emergency Management Act;
- iv) pursuant to section 145 of the Municipal Government Act, RSA 2000, cM-26, Town of Bruderheim Council may pass bylaws in relation to the establishment and functions of, and procedures to be followed by, council committees established by Town of Bruderheim Council;
- v) pursuant to Section 203 of the *Municipal Government Act*, R.S.A. 2000, cM-26, the Council of the Town of Bruderheim, may by bylaw delegate any of its powers, duties or functions under the Municipal Government Act or any other enactment or bylaw to a council committee, the Chief Administrative Officer or a designated officer, unless the Municipal Government Act or other enactment or bylaw provides otherwise.

NOW THEREFORE the Council of the Town of Bruderheim, in the Province of Alberta, duly assembled, hereby enacts as follows:

TITLE

1. This Bylaw may be referred to as the "Emergency Management Bylaw".

DEFINITIONS

- 2. In this bylaw:
 - (a) "Act" means the Emergency Management Act RSA 200, c E-6.8 and regulations thereto, as amended or replaced from time to time;
 - (b) "Agency" means the Town of Bruderheim Emergency Management Agency established under this Bylaw;
 - (c) "Bylaw" means this Emergency Management Bylaw 06-2021;
 - (d) "Chief Administrative Officer" or "CAO" means the individual appointed by Council to the position of Chief Administrative Officer under section 205 of the Municipal Government Act and pursuant to the Chief Administrative Officer Bylaw;
 - (e) "Committee" means the Town of Bruderheim Advisory Committee appointed under this Bylaw;
 - (f) "Council" means the elected municipal council of the Town of Bruderheim;
 - (g) "Councillor" means a member of the Town's municipal Council, including the Mayor;
 - (h) "Deputy Director of Emergency Management" or "DDEM" means the person appointed Deputy Director of the Emergency Management Agency by this bylaw;

- (i) "Director of Emergency Management" or "DEM" means the person appointed Director of the Emergency Management Agency under this bylaw;
- (j) "Disaster" means an event that results in serious harm to the safety, health or welfare of people or in widespread damage to property or the environment;
- (k) "Emergency" means an event that requires prompt co-ordination of action or special regulation of persons or property to protect the safety, health or welfare of people or to limit damage to property or the environment;
- (I) "Emergency Advisory Committee" means the Emergency Advisory Committee established under this bylaw;
- (m) "Emergency Management Act" means the Emergency Management Act, RSA 2000, c E-6.8;
- (n) "Emergency Coordination Centre" or "ECC" means a site within the Town from which civic officials coordinate, direct, monitor, and support the emergency responses and recovery activities during an Emergency, Disaster, or Emergent Event;
- (o) "Emergent Event" means an extraordinary event of circumstance, or a present or imminent threat of loss, that requires prompt coordination of action to protect the safety, health, or welfare of people or to limits damage to property:
- (p) "Incident Command Post" means the primary location for on-scene command and management.
- (q) "Incident Command System" or "ICS" means the standardized management system that is used by the Town which is designed to enable effective, efficient incident management by integrating a combination of facilities, equipment, personnel, procedures, and communications operating within a common organizational structure;
- (r) "Mayor" means the Chief Elected Official of the Town;
- (s) "Minister" means the Minister responsible for the Emergency Management Act;
- (t) "Municipal Emergency Plan" or "MEP" means the Town's emergency plan for coordinating the response to an Emergency or Disaster;
- (u) "State of Local Emergency" or "SOLE" means a state of local emergency declared in accordance with the Act and this Bylaw;
- (v) "Town" means the municipal corporation of the Town of Bruderheim; and
- (w) "Unified Command" means an authority structure:
 - In which the role of incident commander is shared by two or more individuals, each already having authority in a different responding agency; and
 - ii) That allows agencies with different legal, geographic, and functional authorities and responsibilities to work together effectively without affecting individual agency authority, responsibility, or accountability.

EMERGENCY ADVISORY COMMITTEE

- 3. The Emergency Advisory Committee is hereby established.
- 4. Mayor and two councillors will be appointed annually at the organizational meeting to the Emergency Advisory Committee.
- 5. All members of the Emergency Advisory Committee will be entitled to the payment of reasonable expenses in accordance with Town policy.
- 6. The Emergency Advisory Committee will:
 - (a) Review the MEP and related plans and programs on an annual basis;
 - (b) Advise Council on the development and status of the MEP and related programs on an annual basis; and



- (c) Provide guidance and direction to the Agency.
- (d) During an Emergency or Disaster:
 - i) Receive updates regarding the Emergency or Disaster from the Agency.
 - ii) In accordance with the Act and this Bylaw, declare, renew, and terminate the SOLE when appropriate; and
 - iii) Perform any additional powers or duties as described in the Act that have been assigned to it by Council; and
 - iv) Perform any other functions or duties as required by this Bylaw or the Act.
- 7. The Mayor is the chair of Emergency Advisory Committee and will preside at all meetings of the Committee.
- 8. If the Mayor is unable to perform the chair's duties, the Councillor holding the position of vice chair at the time of the meeting will act as the chair.
- 9. The Emergency Advisory Committee will meet at least annually, at the call of the chair of the Committee or the Chief Administrative Officer.
- 10. Except where inconsistent with anything in this bylaw, the Emergency Advisory Committee will follow the procedures governing council committees prescribed in the Town Bylaw 11-2019 the Proceedings of Council Bylaw, as amended or replaced from time to time. This section 14 does not apply to a special meeting of the Emergency Advisory Committee.
- 11. The chair of the Emergency Advisory Committee or Chief Administrative Officer may call a special meeting of the Emergency Advisory Committee where a Councillor or the Chief Administrative Officer considers that an Emergency exists, or may exist, within the Town.
- 12. The chair of the Emergency Advisory Committee or the Chief Administrative Officer must give at least 1 hour notice of the special meeting to as many members of the Emergency Advisory Committee, Council and the public, as possible in the circumstances stating the date, time, and place at which the special meeting is to be held.
- 13. The method of giving notice will be by such means of communication considered by the chair of the Emergency Advisory Committee or Chief Administrative Officer to be most likely to notify the members of the Emergency Advisory Committee and the public.
- 14. Those members of the Emergency Advisory Committee along with Council in attendance at a special meeting of the Emergency Advisory Committee constitute a quorum.

EMERGENCY MANAGEMENT AGENCY

- 15. The Emergency Management Agency is hereby established.
- 16. The members of the Emergency Management Agency are:
 - (a) The DEM; and
 - (b) The DDEM.
- 17. Other organizations may be invited by the DEM to nominate representatives to participate in the emergency responses and recovery activities for an Emergency, Disaster, or Emergent Event, including participating from the ECC, either as an assisting or supporting agency or as part of a Unified Command structure under ICS, including:
 - (a) Health agencies;
 - (b) Utility companies;



- (c) The board of trustees of a school district, school division, or regional division, that operate within the Town;
- (d) Government of Alberta and Government of Canada departments, boards, committees, or agencies;
- (e) Municipalities adjacent to the Town that have entered into mutual aid agreements with the Town;
- (f) Business or industry, or business or industry association, local to the Town;
- (g) Local utility companies;
- (h) Government of Alberta or Government of Canada departments, boards or agencies;
- (i) Any other agency, organization, or individual that, in the opinion of the Director, may assist in the preparation or implementation of emergency management plans and programs.
- 18. Town personnel may be invited by the DEM to participate in the emergency responses and recovery activities for an Emergency, Disaster, or Emergent Event, including participating from the ECC, provided such Town personnel are qualified to so participate in accordance with Town policy.
- 19. The Emergency Management Agency will:
 - (a) Carry out the statutory the statutory powers and duties of Council under the Emergency Management Act, except for the powers and duties delegated by this bylaw to the Emergency Advisory Committee and set out in sections 29 through 32 to this bylaw;
 - (b) Provide advice to the Emergency Advisory Committee as required;
 - (c) Advise the Emergency Advisory Committee on the work of the Emergency Management Agency on at least and annual basis;
 - (d) Ensure that all aspects of Town emergency management planning, preparedness, responses, and recovery activities, are in conformance with ICS;
 - (e) Review the MEP and related plans and programs for the Town on at least an annual basis:
 - (f) Cause the MEP and related plans and programs to be put into operation in an Emergency, Disaster, or Emergent Event;
 - (g) Provide training for Town personnel that my be invited by the DEM in accordance with this bylaw to participate in the emergency responses and recovery activities for an Emergency, Disaster, or Emergent Event, including participating from the ECC;
 - (h) Assist the DEM with the performance of duties and powers of the DEM under this bylaw; and
 - (i) Perform any other function and duties as required by this bylaw or by Council.
- 20. The Chief Administrative Officer is hereby appointed DEM.
- 21. The DDEM will be appointed by Chief Administrative Officer.
- 22. In the absence of the DEM, the DDEM will act as DEM.



23. The DEM is authorized to delegate and authorize further delegations of any powers, duties, and functions delegated to the DEM under this bylaw.

24. The DEM will:

- (a) Prepare and coordinate the MEP and related plans and programs for the Town;
- (b) Act as director of the ECC, or ensure that someone is designated under the MEP to so act, on behalf of the Emergency Management Agency;
- (c) Coordinate all emergency services and other resources, including the activation of the ECC, used in:
 - i) An Emergency, Disaster, or Emergent Event;
 - ii) A recovery from an Emergency, Disaster, or Emergent Event; and
 - iii) The response to a request for assistance from another municipality, the Government of Alberta, or the Government of Canada, related to an Emergency, Disaster, or Emergent Event;
- (d) act as liaison on behalf of the Emergency Management Agency between the Emergency Management Agency and other organizations, including the Alberta Emergency Management Agency;
- (e) perform any other functions and duties as required by this bylaw or by Council.

FINANCIAL

- 25. Council may enter into agreements with and make payments or grants, or both to persons organizations for the provision of services in the development or implementation of the MEP and related plans and programs;
- 26. Subject to section 25, Council may by bylaw that is not advertised, borrow, levy, appropriate, and expend, without the consent of the electors, all sums required for the operation of the Emergency Management Agency;
- 27. Council may, during or within 60 days after the State of Local Emergency, by bylaw that is not advertised but is approved by the Minister, borrow any money necessary to pay expenses caused by the Emergency including payment for services provided by the Government of Alberta or by the Government of Canada when the services were provided at the request of Council;
- 28. Council may expend all money borrowed in accordance with section 25 to pay expenses caused by the Emergency.

DECLARING, RENEWING AND TERMINATING STATE OF LOCAL EMERGENCY

- 29. The powers of Council to declare, terminate or renew a state of local emergency under the Emergency Management Act are hereby delegated to the Emergency Advisory Committee.
- 30. For the purposes of declaring or terminating a SOLE, the Committee may call a meeting without notice.
- 31. In consultation with the Director of Emergency Management and/or Deputy Director of Emergency Management, any one member of the Emergency Advisory Committee many declare a State of Local Emergency.
- 32. The Emergency Advisory Committee may, at any time, when it is satisfied that an Emergency exists or may exist within the Town, by resolution make a declaration of a state of local emergency relating to all or any part of the Town.



- 33. The Emergency Advisory Committee must ensure that the declaration identifies the nature of the Emergency and the area of the Town in which it exists.
- 34. Immediately after the making of a resolution for a declaration of a state of local emergency, the Emergency Management Agency will:
 - (a) cause the details of the declaration to be published by any means of communication that it considers most likely to make known to the population of the area of the Town affected by the contents of the declaration; and
 - (b) Forward a copy of the declaration to the Minister.
- 35. On the making of a declaration of a state of local emergency and for the duration of the state of local emergency, the Emergency Management Agency may do all acts and take all necessary proceedings including the following:
 - (a) Cause the MEP and related plans and programs to be put into operation;
 - (b) Acquire or utilize any real or personal property considered necessary to prevent, combat or alleviate the effects of an Emergency or Disaster;
 - (c) Authorize or require any qualified person to render aid of a type the person is qualified to provide;
 - (d) Control or prohibit travel to or from any area of the Town;
 - (e) Provide for the restoration of essential facilities and the distribution of essential supplies and provide, maintain and co-ordinate emergency medical, welfare and other essential services in any part of the Town;
 - (f) Cause the evacuation of persons and the removal of livestock and personal property from any area of the Town that is or may be affected by a Disaster and make arrangements for the adequate care and protection of those persons or livestock and of the personal property;
 - (g) Authorize the entry into any building or on any land, without warrant, by and person in the course of implementing the MEP and related plans and programs;
 - (h) Cause the demolition or removal of any trees, structures or crops if the demolition or removal is necessary or appropriate in order to reach the scene of a Disaster, or to attempt to forestall its occurrence or to combat its progress;
 - (i) Procure or fix prices for food, clothing, fuel, equipment, medical supplies, or other essential supplies and the use of any property, services, resources or equipment within any part of the Town for the duration of the state of local emergency;
 - (j) Authorize the conscription of persons needed to meet an Emergency.
- 36. A declaration of a state of local emergency ceases to be of any force or effect on the making of an order for a state of emergency by the Lieutenant Governor in Council relating to the same are of the Town.
- 37. A declaration of a state of local emergency lapses 7 days after its making by the Emergency Advisory Committee unless it is earlier cancelled by the Minister or terminated by the Emergency Advisory Committee or unless it is renewed by the Emergency Advisory Committee.
- 38. A declaration of a state of local emergency related to pandemic lapses 90 days after its making by the Emergency Advisory Committee unless it is earlier cancelled by the Minister or terminated by the Emergency Advisory Committee or unless it is renewed by the Emergency Advisory Committee.

M

- 39. The power of Council to terminate a state of local emergency under the Emergency Management Act is herby delegated to the Emergency Advisory Committee.
- 40. When the Emergency Advisory Committee is of the opinion that an Emergency no longer exists in the area of the Town in relation to which a declaration of a State of Local Emergency was made, it will by resolution terminate the declaration of a State of Local Emergency in respect of that area.
- 41. Immediately after:
 - (a) The passage of a resolution terminating a declaration of a state of local emergency,
 - (b) The cancellation by the Minister of a declaration of a state of local emergency, or
 - (c) The termination by lapse of time of a declaration of a state of local emergency.

the Emergency Management Agency will cause the details of the declaration or cancellation or the fact of termination by lapse of time to be published by and means of communication that it considers is most likely to make known to the majority of the population of the area affected by the contents of the declaration or cancellation of the fact of the termination.

PROTECTION FROM LIABILITY

42. No action lies against the Emergency Advisory Committee, the Emergency Management Agency, Council, and any member of the committee and agency or any person acting under the Committee's or Agency's direction or authorization for anything done or omitted to be done in good faith while carrying out a power or duty under this Bylaw during a SOLE.

GENERAL

- 43. Bylaw 06-2021 is repealed.
- 44. This Bylaw comes into force on the day it is passed.
