BYLAW NO. 08-2018

A BYLAW OF THE TOWN OF BRUDERHEIM TO REPEAL THE LAMONT COUNTY ALBERTA'S HEARTLAND AREA STRUCTURE PLAN BYLAW 620/00 AS IT APPLIES TO LANDS WITHIN THE TOWN OF BRUDERHEIM

WHEREAS the Municipal Government Act, R.S.A. 2000, as amended ("the Act") provides that a Municipal Council may repeal a bylaw;

AND WHEREAS the Council of the Town of Bruderheim wishes to repeal the Lamont County Alberta's Heartland Area Structure Plan Bylaw 620/00 as it affects certain lands;

AND WHEREAS the lands legally described as

ALL THAT PORTION OF THE WEST HALF OF SECTION THIRTY-THREE (33), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BRUDERHEIM;

ALL THAT PORTION OF THE SOUTH HALF OF SECTION THIRTY-TWO (32), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BRUDERHEIM;

THE NORTHEAST QUARTER OF SECTION TWENTY-NINE (29), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN;

ALL THAT PORTION OF THE NORTHWEST QUARTER OF SECTION TWENTY-EIGHT (28), TOWNSHIP FIFTY-FIVE (55), RANGE TWENTY (20), WEST OF THE FOURTH (4) MERIDIAN NOT WITHIN THE TOWN OF BRUDERHEIM;

(the "Lands) were annexed to the Town of Bruderheim from Lamont County effective July 1, 2017;

AND WHEREAS in accordance with s. 135(1)(d) of the <u>Municipal Government Act</u>, R.S.A. 2000, c. M-26, as amended, the Lamont County Alberta's Heartland Area Structure Plan Bylaw 620/00 continues to apply to the Lands until the Town repeals the Lamont County Alberta's Heartland Area Structure Plan Bylaw 620/00 as it affects with the Lands;

NOW THEREFORE the Council of the Town of Bruderheim, duly assembled, enacts as follows:

- 1. Bylaw 620/00, the Lamont County Alberta's Heartland Area Structure Plan, as amended, is hereby repealed.
- 2. This Bylaw comes into full force and takes effect on the date of third and final reading.
